
Burning Mechanism

The total supply of MUSK coins is 1,000,000,000. Out of this, 900,000,000 coins will be allocated for sale in nine successful investment rounds, each consisting of 100,000,000 coins. The remaining 100,000,000 coins will be retained. To ensure flexibility and maintain the token's value, any coins not sold in these investment rounds will be subject to a potential burn, reducing the total supply and enhancing scarcity. This structured approach aims to create a balanced and dynamic market, aligning with the long-term vision of the Muskatier project.

Token Strategy

All pre-IPO investments, whether in SpaceX or other projects will be kept in reserve. These reserves will be utilized only after the sale of the first 100 million tokens.

A part of proceeds from the sale of the tokens will be invested in the pre-IPO investments. To be specific, for the sale of the first 100 million tokens, 10% of the proceeds will be invested.
